CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DUANE FLEET
LA GRANDE, OREGON 97850

confirms the right to use the waters of the GRANDE RONDE RIVER AND FLEET LOOP RESERVOIR NO. 1, CONSRUCTED UNDER APPLICATION R-41214, PERMIT R-4654, a tributary to the SNAKE RIVER for IRRIGATION OF 372.65 ACRES AND SUPPLEMENTAL IRRIGATION OF 195.15 ACRES.

This right was perfected under Permit S-30816. The date of priority is AUGUST 11, 1965. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 4.64 CUBIC FEET PER SECOND FROM THE GRANDE RONDE RIVER AND 245.62 ACRE FEET STORED WATER FROM FLEET LOOP RESERVOIR NO. 1, or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit number R-4654, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
