## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of TWO WELLS, within the MILL CREEK Basin for IRRIGATION of 74.7 ACRES.

This right was perfected under Permit G-5567. The date of priority is MAY 23, 1972. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.66 CUBIC FOOT PER SECOND, if available at the original well, Well 5, or its equivalent in case of rotation, measured at the wells.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

When required by the Department the water user shall install in-line flow meters or other suitable measuring devices for measuring and recording the quantity of water used. The type and plans of the measuring devices must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Water shall be acquired from the same aquifer as the original point of appropriation.

This certificate is issued to confirm an ADDITIONAL POINT OF APPROPRIATION approved by an order of the Water Resources Director entered FEBRUARY 28, 1991, at Special Order Volume 45, Page 117, approving Transfer Application 6438, and together with Certificate 65345, supercedes Certificate 45551, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
