CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of SNAKE RIVER, tributary to COLUMBIA RIVER, for IRRIGATION of 112.74 ACRES.

This right was perfected under Permit S-1150. The date of priority is FEBRUARY 17, 1912. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.34 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer. The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

When required by the Department, the water users shall install and maintain headgates, inline flow meters, weirs, or other suitable devices for measuring and recording the quantity of water diverted. The type and plans of the headgates and measuring devices must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The water users shall maintain and operate a fish screening and/or by-pass device, as appropriate, at each point of diversion consistent with the Oregon Department of Fish and Wildlife's operational and maintenance standards.

The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.

This certificate is issued to confirm HISTORIC CHANGES IN POINTS OF DIVERSION approved by an order of the Water Resources Director entered <u>SEP 2 3 2009</u>, approving Transfer Application T-10572 and Transfer Application T-10717, and together with Certificate 85823 supersedes Certificate 75711, State Record of Water Right Certificates.
