CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of DREWS CREEK, a tributary to GOOSE LAKE for IRRIGATION of 10520.09 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Lake County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 16, at Page 478. The date of priority is JANUARY 21, 1907, JULY 31, 1908.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 386.36 CUBIC FEET PER SECOND (CFS); being 203.69 CFS from DREWS CREEK AND RESERVOIR and 182.67 CFS from COTTONWOOD CREEK AND RESERVOIR, or its equivalent in case of rotation, measured at the points of diversion.
