CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of A WELL (Well #14) in the Umatilla River Basin for MUNICIPAL USE.

This right was perfected under Permit G-465. The date of priority is MARCH 5, 1957. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.21 CUBIC FEET PER SECOND, if available at the original well; NW¼ NE¼, SECTION 7, T 2 N, R 32 E, W.M.; 910 FEET SOUTH & 1350 FEET WEST FROM NE CORNER, SECTION 7, or its equivalent in case of rotation, measured at the point of appropriation.

In addition, the amount of water appropriated under this right in combination with CERTIFICATE 85848 for municipal use is limited to an amount beneficially used and shall not exceed 1.7 cubic feet per second, or its equivalent, and shall be further limited to a diversion of not to exceed 607.2 acre-feet for year round use.

The point of diversion is located as follows:

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The quantity of water diverted at the new point of appropriation (well), together with the quantity diverted at the old point of appropriation, shall not exceed the quantity of water lawfully available from the original point of appropriation.

This certificate is issued to confirm a change in PLACE OF USE, POINT OF APPROPRIATION AND CHARACTER OF USE approved by an order of the Water Resources Director entered MAY 16, 2002, at Special Order Volume 56, Page 331, approving Transfer Application 8434, and together with Certificate 79473, supercedes Certificate 28602, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

Water may be applied to lands which are not specifically described above, provided the holder of this right complies with ORS 540.510(3).
