## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of WILLAMETTE RIVER and WILLAMETTE BASIN PROJECT RESERVOIRS CONSTRUCTED UNDER PERMITS R-1625 AND R-5363, tributaries to the COLUMBIA RIVER, for SUPPLEMENTAL IRRIGATION of 160.00 ACRES.

This right was perfected under Permit S-41803. The date of priority is FEBRUARY 28, 1977. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.50 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated from direct flow, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoirs constructed under Permits R-1625 and R-5363, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and is subject to the terms and conditions of contract No. 7-07-10-W0026, or a satisfactory replacement, between the Bureau of Reclamation and the applicant, a copy of which is on file in the records of Water Resources Department.

Pursuant to ORS 536.075 and OAR 137-004-9080, you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate at any time before it has issued, and after the time has expired for the completion of the appropriation under the permit, or within three months after issuance of the certificate.
