The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed a reasonable amount for livestock use, and 0.60 CUBIC FOOT PER SECOND, or its equivalent in case of rotation for irrigation use, measured at the point of diversion.
