## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ROBERT AND CAROL KERBY 25963 HIGHWAY 20 W HINES, OREGON 97738

confirms the right to use the waters of WILLOW CREEK RESERVOIR CONSTRUCTED UNDER PERMIT R-5084, a tributary of the SILVIES RIVER, for SUPPLEMENTAL IRRIGATION OF 67.5 ACRES.

This right was perfected under Permit S-32934. The date of priority is AUGUST 10, 1967. The right is limited to not more than 420.2 ACRE-FEET STORED WATER ONLY or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
