CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

BAKER VALLEY IRRIGATION DISTRICT P.O. BOX 127 BAKER CITY, OREGON 97814

confirms the right to use the waters of POWDER RIVER, a tributary to the SNAKE RIVER for IRRIGATION OF 1646.95 ACRES AND STORAGE OF 350 ACRE FEET OF WATER IN BAKER RESERVOIR.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Baker County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 14, at Page 390. The date of priority is MARCH 1905.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 41.2 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year.
