CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

TRIPLE S MOUNTAIN HORSE RANCH, LLC 6222 HWY 140 EAGLE POINT, OREGON 97524

confirms the right to use the waters of THREE SPRINGS and a RESERVOIR (perfected under Permit R-971) tributaries of LITTLE BUTTE CREEK, for SUPPLEMENTAL IRRIGATION of 12.0 acres.

This right was perfected under Permit S-18746. The date of priority is April 25, 1949. The amount of water to which this right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purpose and shall not exceed 15 gallons per minute (gpm), being 4 gpm from East Spring, 4 gpm from Middle Spring and 7 gpm from West Spring, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season from April 2 to October 31 of each year from direct flow and storage from the reservoir, and shall be still further limited to a diversion of not to exceed 15 gallons per minute. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
