## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RODNEY L. AND LEE ANNA HADLEY PO BOX 32 BLY OR 97622

confirms the right to use the waters of SOUTH FORK SPRAGUE RIVER, tributary to SPRAGUE RIVER for IRRIGATION of 297.1 ACRES, being irrigation of 160 acres in Tract No. 1; 42.8 acres in Tract No. 2; 40 acres in Tract No. 3; and 54.3 acres in Tract No. 4.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Klamath County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 10, at Page 236. The date of priority is SEPTEMBER 8, 1880 for Tract No. 1, NOVEMBER 2, 1885 for Tract No. 2, DECEMBER 14, 1886 for Tract No. 3, and JANUARY 5, 1894 for Tract No. 4.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed one-fortieth of a cubic foot per second per acre, prior to June 15, and one-eightieth of a cubic foot per second per acre after June 15, with a total limitation of three acre feet per acre from March 1<sup>st</sup> to October 1<sup>st</sup> of each year, or its equivalent in case of rotation, measured at the point of diversion.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second, prior to June 15, and ONE EIGHTIETH of one cubic foot per second per acre after June 15, with a total limitation of 3.0 acre feet per acre from March 1 to October 1 of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer. The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

A description of the place of use to which this right is appurtenant is as follows:
