## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of TWO WELLS, within the EAST PRONG WALLA WALLA RIVER BASIN for IRRIGATION of 9.6 ACRES.

This right was perfected under Permit G-6153. The date of priority is MAY 29, 1974. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.12 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the wells.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

Water at the additional point of appropriation shall be acquired from the same aquifer (water source) as the original point of appropriation.

The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
