confirms the right to use the waters of EMERSON WASTEWAY, a tributary of the Snake River, for IRRIGATION of 329.2 ACRES.

This right was perfected under Permit 47520. The date of priority is JANUARY 14, 1983. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 8.23 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall also be limited to the water available at the point of diversion, and shall not carry with it the right to compel the continuance of the waste water.

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate at any time before it has issued, and after the time has expired for the completion of the appropriation under the permit, or within three months after issuance of the certificate.
