confirms the right to use the waters of WILLIAMSON RIVER for IRRIGATION of 105.7 ACRES.

This right was perfected under Permit 45058. The date of priority is OCTOBER 22, 1979. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.91 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion.

In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate at any time before it has issued, and after the time has expired for the completion of the appropriation under the permit, or within three months after issuance of the certificate.
