## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

EAGLE POINT IRRIGATION DISTRICT PO BOX 157 EAGLE POINT OR 97524 SUPERSEDED BY CERT. NO. 92239+89373 T-11043

confirms the right to use the waters of BIG BUTTE CREEK, a tributary to the ROGUE RIVER for IRRIGATION of 5.0 ACRES.

This right was perfected under Permit 6396. The date of priority is APRIL 21, 1915. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.06 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
