This right was confirmed by decree of the Circuit Court of the State of Oregon for Douglas County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 11, at Page 1.

The date of priority is SEPTEMBER 30, 1907.

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The water user shall maintain a fish screen at the new point of diversion.

Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
