CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CYNTHIA A. EDWARDS 13238 EAST EVANS CREEK RD ROGUE RIVER, OR 97537

confirms the right to use the waters of EVANS CREEK, tributary to ROGUE RIVER for IRRIGATION of 7.2 ACRES.

This right was perfected under Permit S-6124. The date of priority is DECEMBER 1, 1923. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.09 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The water user shall maintain and operate fish screen and/or by-pass device, as appropriate, at the point of diversion consistent with ODFW's operational and maintenance standards.

The water user shall maintain and operate the in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted, as required by the Department.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered NOVEMBER 28, 2007, at Special Order Volume 73, Page 680, approving Transfer Application 10395, and together with Certificate 83539, supersedes Certificate 43985, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
