confirms the right to use the waters of MAY CREEK, tributary to EVANS CREEK for IRRIGATION of 0.8 ACRE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Jackson County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 4, at Page 1. The date of priority is 1901.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.014 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The quantity of water diverted at the new reach within which a portable pump diverts water, shall not exceed the quantity of water lawfully available at the original point of diversion.

Diversion of water under this right is limited to availability of water at the original diversion point on May Creek being:

When May Creek goes dry, irrigation will end under this right, even if there is still water in Evans Creek.

The water user shall maintain and operate the fish screen and/or by-pass device, as appropriate, at the point of diversion consistent with ODFW's operational and maintenance standards.

The water user shall maintain and operate the in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted, as required by the Department.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered NOVEMBER 28, 2007, at Special Order Volume 73, Page 680, approving Transfer Application 10395, and together with Certificate 83542, supersedes Certificate 51335, State record of Water Right Certificates.

This right is subject to all other conditions or limitations contained in said decree.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
