confirms the right to use the waters of a WELL in the WYCHUS CREEK (formerly Squaw Creek) BASIN for SUPPLEMENTAL IRRIGATION of 74.2 ACRES.

This right was perfected under Permit G-7092. The date of priority is DECEMBER 26, 1976. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.93 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH (1/80) of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer. The right is limited to any deficiency in the available supply of any prior right existing for the same land. The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. A description of the place of use to which this right is appurtenant is as follows:


The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

This certificate corrects scrivener errors in the certificate recorded at page 81475, State Record of Water Right Certificates. Certificate 81475 erroneously included 2.5 acres of water rights, and the proportionate quantity of water, in the NW NE quarter-quarter of Section 26 canceled by the order approving Transfer Application 9571. This certificate supersedes Certificate 81475.

This certificate describes that portion of the water right confirmed by Certificate 74142, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered September 21, 2005, and recorded at Special Order Volume 67, pages 177 to 182, approving Transfer Application 9571.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
