## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of HORSE HEAVEN CREEK, tributary to CROOKED RIVER for IRRIGATION of 25.0 ACRES, DOMESTIC, AND STOCK USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Crook County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 1, at Page 449. The date of priority is 1905. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed A REASONABLE AMOUNT FOR DOMESTIC AND STOCK USE AND 0.32 CUBIC FOOT PER SECOND for IRRIGATION, or its equivalent in case of rotation, measured at the point of diversion.

When required by the Department, the water user shall install and maintain a headgate, in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm a change in PLACE OF USE AND POINT OF DIVERSION approved by an order of the Water Resources Director originally entered December 28, 2001, at Special Order Volume 55, Pages 1372 through 1383, approving Transfer Application T-8827, further superseded by an order of the Water Resources Director entered April 6, 2007, at Special Order Volume 71, Pages 462 through 474, correcting a scrivener's error, and supersedes Certificate 577, State record of Water Right Certificates.
