## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of HORSE HEAVEN CREEK, tributary to CROOKED RIVER for IRRIGATION of 192.0 ACRES, DOMESTIC USE, AND STOCK USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Crook County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 1, at Page 449. The date of priority is 1889. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed A REASONABLE AMOUNT FOR DOMESTIC AND STOCK USE AND 2.40 CUBIC FEET PER SECOND for IRRIGATION, or its equivalent in case of rotation, measured at the points of diversion.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
