CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of CROOKED RIVER, tributary to DESCHUTES RIVER for IRRIGATION of 59.0 ACRES.

This right was perfected under Permit 9562. The date of priority is MARCH 17, 1930. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.74 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion (POD) are located as follows:
