CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

NEAL & ANNA DOW 28000 SE PAULINA HWY PRINEVILLE OR 97754

confirms the right to use the waters of HORSE HEAVEN CREEK AND RESERVOIR, CONSTRUCTED UNDER PERMIT R-1130, tributaries to CROOKED RIVER for IRRIGATION of 73.4 ACRES FROM NATURAL FLOW FROM HORSE HEAVEN CREEK AND STORAGE, AND SUPPLEMENTAL IRRIGATION of 106.2 ACRES FROM STORAGE ONLY.

This right was perfected under Permit 20200. The date of priority is MARCH 2, 1951. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 4.49 CUBIC FEET PER SECOND, AND SHALL BE FURTHER LIMITED TO A DIVERSION OF 1.83 CUBIC FEET PER SECOND FROM DIRECT FLOW OF HORSE HEAVEN CREEK, or its equivalent in case of rotation, measured at the points of diversion.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated from direct flow, and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-1130.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This certificate is issued to confirm a change in PLACE OF USE AND POINT OF DIVERSION approved by an order of the Water Resources Director originally entered December 28, 2001, at Special Order Volume 55, Pages 1372 through 1383, approving Transfer Application T-8827, further superseded by an order of the Water Resources Director entered April 6, 2007, at Special Order Volume 71, Pages 462 through 474, correcting a scrivener's error, and supersedes Certificate 24503, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
