CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of BONNIEVIEW RANCH RESERVOIR CONSTRUCTED UNDER PERMIT R-6551, tributary to CROOKED RIVER for SUPPLEMENTAL IRRIGATION of 179.6 ACRES.

This right was perfected under Permit 41174. The date of priority is DECEMBER 8, 1976. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 249.3 ACRE FEET OF STORED WATER ONLY, or its equivalent in case of rotation, measured at the points of diversion.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
