confirms the right to use the waters of HORSE HEAVEN CREEK, tributary to CROOKED RIVER for IRRIGATION of 121.6 ACRES.

This right was perfected under Permit E-235. The date of priority is JANUARY 18, 1915. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.52 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.
