CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ROSEBURG COUNTRY CLUB

confirms the right to use the waters of NORTH UMPQUA RIVER, tributary to UMPQUA RIVER for COMMERCIAL USE, IRRIGATION of 55.7 ACRES, AND POND MAINTENANCE.

This right was perfected under Permit S-7665. The date of priority is NOVEMBER 10, 1926. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.68 CUBIC FOOT PER SECOND (CFS), BEING 0.01 CFS FOR COMMERCIAL USE (included in rate allocated to irrigation), 0.67 CFS FOR IRRIGATION, AND 0.01 CFS FOR POND MAINTENANCE, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:



When required by the Department, the water user shall install, maintain and operate an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The types and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in CHANGE IN PLACE OF USE AND CHANGES IN CHARACTER OF USE approved by an order of the Water Resources Director entered January 28, 2008, at Special Order Volume 74, Pages 74 to 77, approving Transfer Application T-6847, and supersedes Certificate 8887, State record of Water Right Certificates.
