## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DAVID A. and/or JOANN ORR 8892 NW CAMPBELL RANCH ROAD PRINEVILLE, OR 97754

confirms the right to use the waters of a WELL in the DESCHUTES RIVER BASIN for IRRIGATION OF 2.4 ACRES and SUPPLEMENTAL IRRIGATION OF 2.5 ACRES.

This right was perfected under Permit G-1119. The date of priority is SEPTEMBER 5, 1958. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.062 CUBIC FOOT PER SECOND, being 0.031 FOR IRRIGATION AND 0.031 FOR SUPPLEMENTAL IRRIGATION or its equivalent in case of rotation, measured at the well.

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
