CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of CULLABY CREEK, a tributary of CULLABY LAKE, for FLOODING CRANBERRY BOGS.

This right was perfected under Permit 9739. The date of priority is JULY 15, 1930. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 4.70 CUBIC FEET PER SECOND, AND SHALL BE FURTHER LIMITED TO 6.0 ACRE-Feet PER ACRE PER YEAR NOR MORE THAN 0.75 ACRE FOOT PER ACRE THROUGHOUT ANY THIRTY DAY PERIOD, or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion (POD) are located as follows:

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The quantity of water diverted at the additional point of diversion, together with that diverted at the old points of diversion, shall not exceed the quantity of water lawfully available at the original points of diversion.

NOTICE OF RIGHT TO RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm an ADDITIONAL POINT OF DIVERSION approved by an order of the Water Resources Director entered January 18, 2006, at Special Order Volume 67, Page 704, approving Transfer Applications 7747, and together with Certificate 81775 supersedes Certificate 9733, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
