confirms the right to use the waters of the WEST FORK WILLIAMS CREEK, a tributary to WILLIAMS CREEK for IRRIGATION of 20.1 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Josephine County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 2, at Page 339. The date of priority is DECEMBER 1908. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.285 CUBIC FOOT PER SECOND.
