CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

SAM LEFORE, JR.

confirms the right to use the waters of A WELL within the WALLA WALLA RIVER BASIN, for SUPPLEMENTAL IRRIGATION of 49.2 acres.

This right was perfected under Permit U-82. The date of priority is September 27, 1934. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.62 cubic feet per second (cfs) or its equivalent in case of rotation, if available at the original well. The original well is located as follows .

6 N	35 E	WM	36	NW ¼ of SE SE

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE THIRTIETH of one cfs per acre, or its equivalent for each acre irrigated during the irrigation season of each year.

The point of appropriation is located as follows:

Twp	Rng	Mer	Sec	Q-Q	Measured Distance
6 N	35 E	WM	36	SW SE	650 FEET NORTH AND 1675 FEET WEST FROM THE SE CORNER OF SECTION 36

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer. The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.


A description of the place of use to which the irrigation portion of this right is appurtenant is as follows:

This final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate confirms an order of the Water Resources Director entered on May 31, 2003, and recorded in Special Order Volume 57, Page 884, approving Transfer Application T-8855 and included in the petition by Walla Walla River Irrigation District under ORS 541.329 for mapping water rights within a district.
