confirms the right to use the waters of Walla Walla River, a tributary of Columbia River, for irrigation of 4.88 acres.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director, in Volume 12 at Page 9. The date of priority is 1891.

The use is limited to 1.5 miner's inches per acre, or 0.18 cubic foot per second (cfs), or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

This certificate confirms an order of the Water Resources Director entered on May 27, 2010, and recorded in Special Order Volume 80, Page 154 approving a petition by Walla Walla River Irrigation District under ORS 541.329 for mapping water rights within a district. This certificate supersedes the relevant portions of water right Certificate 13297.

This final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
