## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LEO DUCHAM 84462 GRANT ROAD MILTON FREEWATER, OR 97862

confirms the right to use the waters of a well for IRRIGATION of 0.35 ACRES and SUPPLEMENTAL IRRIGATION of 1.65 ACRES.

This right was perfected under Permit G-1302 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 10, 1959.

The amount of water to which this right is entitled for the purposes aforesaid, is limited to an amount actually beneficially used and shall not exceed 0.03 cubic foot per second (cfs), being 0.005 cfs for irrigation and 0.025 cfs for supplemental irrigation or its equivalent in case of rotation, measured at the point of appropriation.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.

A description of the place of use to which this right is appurtenant is as follows:
