## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of WALLA WALLA RIVER, a tributary of SNAKE RIVER for IRRIGATION of 0.58 ACRES.

This right was perfected under Permit S-1299 of the State Engineer, and the use of said waters has been perfected in accordance with the laws of Oregon and duly confirmed by order of the State Water Board of Oregon, made and entered of record in the Record of Proceedings of said Board, at Salem, in Volume 1, at Page 236, on the 8<sup>th</sup> day of February, 1917. The date of priority is July 23, 1912.

The use is limited to 0.007 cubic foot per second (cfs), or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion are located as follows:

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer. The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

Rights to the use of water for power purposes are limited to a period of forty years from the date of priority of the right, as herein set forth, subject to a preference right of renewal under the laws existing at the date of the expiration of the right for power purposes, as hereby confirmed and limited.

A description of the place of use to which this right is appurtenant is as follows:
