confirms the right to use the waters of Walla Walla River, a tributary of Columbia River, for irrigation of 36.07 acres and stock use.

These rights was confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director, in Volume 12 at Page 9. The dates of priority are 1893, 1892, 1887, 1898, 1894, 1886, and 1905, as described below.

The use is limited to 1.5 miner's inches per acres, or 1.35 cubic foot per second (cfs), or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described, and shall be subject to all other conditions and limitations contained in the above described decree.


