CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

OLYMPIC FOREST PRODUCTS – A DIVISION OF RSG FOREST PRODUCTS 69480 BANZER ROAD MIST OR 97016

confirms the right to use the waters of NEHALEM RIVER, tributary to NEHALEM BAY for INDUSTRIAL USE and RESERVOIR MAINTENANCE of a reservoir constructed under Permit R-14492.

This right was perfected under Permit S-13703. The date of priority is MAY 12, 1939. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.71 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the stream. Use shall be limited to the irrigation season of each year.

The total amount of water diverted during the irrigation season of each year shall not exceed a total of 164.75 ACRE-FEET for INDUSTRIAL USE and RESERVOIR MAINTENANCE.
