CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ROCK CREEK DISTRICT IMPROVEMENT COMPANY
P.O. BOX 28
WAMIC, OREGON 97063

confirms the right to use the waters of ROCK CREEK, THREEMILE CREEK, NORTH FORK OF GATE CREEK AND ROCK CREEK RESERVOIR, CONSTRUCTED UNDER PERMIT R-780, tributaries of the WHITE RIVER, for IRRIGATION OF 320.4 ACRES, SUPPLEMENTAL IRRIGATION OF 595.6 ACRES, DOMESTIC USE FOR 12 FAMILIES AND STOCK USE.

This right was perfected under Permit S-15519. The date of priority is MARCH 13, 1939.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated UP TO JULY 1ST OF EACH YEAR AND THEREAFTER not to exceed ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated FROM DIRECT FLOW AND SHALL BE FURTHER LIMITED TO A DIVERSION OF NOT TO EXCEED ONE ACRE FOOT PER ACRE DURING ANY 30-DAY PERIOD UP TO JULY 1ST OF EACH YEAR AND NOT TO EXCEED 3.0 ACRE-FEET PER ACRE FOR EACH ACRE IRRIGATED DURING THE IRRIGATION SEASON OF EACH YEAR FROM DIRECT FLOW AND STORAGE FROM ROCK CREEK RESERVOIR CONSTRUCTED UNDER PERMIT R-780. THE USE OF WATER FOR STOCK AND DOMESTIC PURPOSES SHALL BE IN ACCORDANCE WITH PARAGRAPH 25 OF THE WHITE RIVER DECREE DATED NOVEMBER 30, 1923, IN WASCO COUNTY, OREGON.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review of the order must be filed within 60 days of the date of service.

This certificate is used to correct a scrivener's error in the place of use for livestock described in Certificate 84761. This Certificate supersedes Certificate 84761, and describes the portion of water right Certificate 73996 NOT modified by the provisions of an order of the Water Resources Director entered November 6, 2008, and recorded at Volume 76, Page 688, approving Transfer Application 10014.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
