confirms the right to use the waters of A WELL, tributary to MILL CREEK BASIN for MUNICIPAL USE.

This right was perfected under Permit U-189. The date of priority is OCTOBER 4, 1945. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.69 CUBIC FOOT PER SECOND and restricted to use during the irrigation season of each year from April 1 to October 1, or its equivalent in case of rotation, measured at the point of diversion.
