CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ESTATE OF MARY ELLEN LEONARD KERBY, OR 97531

confirms the right to use the waters of SUCKER CREEK, a tributary to the EAST FORK ILLINOIS RIVER for IRRIGATION OF 16.25 ACRES, BEING 13.0 ACRES FOR TRACT 3, AND 3.25 ACRES FOR TRACT 4.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Josephine County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 1, at Page 229; Volume 5, at Page 420; and Volume 5, at Page 394. The dates of priority are 1889 FOR TRACT 3 AND 1908 FOR TRACT 4.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.24 CUBIC FOOT PER SECOND FOR TRACT 3 AND 0.04 CUBIC FOOT PER SECOND FOR TRACT 4, or its equivalent in case of rotation, measured at the point of diversion from the source, and that the use of said water for irrigation purposes shall be confined to the irrigation season April 1 to October 31 each year.
