## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JAMEY MAZZOTTA PO BOX 187 BELLA VISTA, CA 96008

confirms the right to use the waters of SOUTH FORK JOHN DAY RIVER, a tributary of JOHN DAY RIVER, for the purpose of 16.8 ACRES PRIMARY IRRIGATION AND 2.3 ACRES SUPPLEMENTAL IRRIGATION.

This right was perfected under Permit S-47898. The date of priority is JULY 1, 1983. The right is limited to not more than 0.47 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the points of diversion from the source.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acres irrigated and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
