## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

TOM AND NANCY VANASCHE 37731 NE BOND RD ALBANY OR 97321

confirms the right to use the waters of the SOUTH SANTIAM RIVER, tributary to SANTIAM RIVER for IRRIGATION of 38.9 ACRES.

This right was perfected under Permit 47557. The date of priority is MARCH 29, 1983. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.49 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered November 30, 1992, at Special Order Volume 46, Page 517, approving Transfer Application 6554, and supersedes Certificate 62107, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
