## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JAMES BUTSCH 7877 SW EDGEWATER E WILSONVILLE OR 97070

confirms the right to use the waters of WELL 1 AND WELL 3, within the ZOLLNER CREEK BASIN for IRRIGATION of 65.7 ACRES AND SUPPLEMENTAL IRRIGATION OF 295.0 ACRES.

This right was perfected under Permit G-7508. The date of priority is MAY 16, 1977. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.0 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing fro the same land and shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The quantity of water diverted at the additional point of appropriation (well) shall not exceed the quantity of water available from the original point of appropriation.

When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Water shall be acquired from the same aquifer as the original point of appropriation, identified as the Troutdale Formation.

This certificate is issued to confirm an ADDITIONAL POINT OF APPROPRIATION approved by an order of the Water Resources Director entered June 10, 1992, at Special Order Volume 46, Page 296, approving Transfer Application 6481, and together with Certificate 67382, supersedes Certificate 56441, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
