CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CYRUS AND REBECCA FIELD 2001 NW OCEANVIEW DR NEWPORT OR 97365

confirms the right to use the waters of LAKE CREEK, tributary to SOUTH FORK LAKE CREEK for RECREATION, INCLUDING SWIMMING, BOATING, FISHING AND WILDLIFE ATTRACTION IN A DITCH AND THROUGH A POND ON THE WATER USER'S PROPERTY.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Deschutes County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 9, at Page 362. The date of priority is 1888.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.03 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The total quantity of water which may be diverted, during the irrigation season of each year, for this use shall not exceed 6.0 acre feet, measured at the point of diversion.

The point of diversion is located as follows:

When required by the Department, the water user shall install and maintain a headgate, in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plan of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

NOTICE OF RIGHT TO RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
