CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

COLAHAN ENTERPRISES 45190 HWY 31 PAISLEY, OREGON 97636

confirms the right to use the waters of CHEWAUCAN RIVER, a tributary of LAKE ABERT, for IRRIGATION OF 309.1 ACRES.

This right was perfected under Permit 31344. The date of priority is OCTOBER 17, 1966. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 7.05 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. Irrigation from October 1 to April 1 of the following year is also allowed. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This certificate corrects scrivener errors in the certificate recorded at page 81170, State Record of Water Right Certificates. Certificate 81170 erroneously described use limitations and place of use. Certificate 81170 was a correcting certificate issued to supersede Certificate 64859. Certificate 64859 confirmed the change in point of diversion authorized by an order of the director entered on April 9, 1982, and recorded in Special Order Volume 36, pages 101 to 102, approving Transfer Application T-4976. This certificate supersedes Certificate 81170.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
