Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate at any time before it has issued, and after the time has expired for the completion of the appropriation under the permit, or within three months after issuance of the certificate.

This certificate is issued to describe the portion of the right not diminished by the Superseding Order of Diminution of City of Helix Certificate 40935, Special Order Volume 81 Page 472 and 473, and supersedes Certificate 76270.

The right to the use of water for the above purpose is restricted to beneficial use.
