confirms the right to use the waters of UNNAMED DRAINAGEWAY for SUPPLEMENTAL IRRIGATION of 45.0 ACRES.

This right was perfected under Permit S-43932. The date of priority is JANUARY 9, 1979. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.12 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 6 acre-feet per acre for each acre irrigated during the irrigation season of each year. Provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein; provided further that although declared herein to be supplemental irrigation the right may, in the interest of conserving the ground water supplies, be exercised at times when water is available in the ground water supply provided that the total quantity diverted from all sources of supply does not exceed the limitation allowed herein.

In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate at any time before it has issued, and after the time has expired for the completion of the appropriation under the permit, or within three months after issuance of the certificate.
