confirms the right to use the waters of PENDLETON HOSPITAL DEEP WELL, tributary to UMATILLA RIVER for MUNICIPAL USE.

This right was perfected under Permit U-670. The date of priority is OCTOBER 18, 1954. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.47 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the well.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
