## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GLENN S. CHOWNING PO BOX 862 HERMISTON, OR 97838

confirms the right to use the waters of DEEP WELL NO. 2 and HILLVIEW WELL NO. 4, within the UMATILLA BASIN for IRRIGATION of 0.8 ACRES and for SUPPLEMENTAL IRRIGATION of 10.7 ACRES.

The right was perfected under G-9811. The date of priority is FEBRUARY 4, 1982. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.14 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The wells are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acrefeet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
