CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

TERENCE E. & ROBERTA DEAN

confirms the right to use the waters of CROOKED RIVER, tributary to DESCHUTES RIVER for IRRIGATION of 44.0 ACRES AND LIVESTOCK.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Crook County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 1, at Page 449. The date of priority is APRIL 24, 1909. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.55 CUBIC FOOT PER SECOND, if available at the original point of diversion, or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion (POD) are located as follows:

This right includes the use of such quantity of water as is reasonably necessary for household and stock use; and for stock use, the amount so diverted and used shall not exceed the rate of ONE-FORTIETH cubic foot per second for each one thousand head of stock; and the quantity diverted for irrigation during the irrigation season shall include when it is so diverted such amount as may be reasonably necessary for said stock and domestic purposes; and the right to divert and use the water for stock and domestic purposes continues throughout the year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer

A description of the place of use to which this right is appurtenant is as follows:

**NOTICE OF RIGHT TO RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.


The quantity of water diverted at the new points of diversion, together with that diverted at the original diversion, shall not exceed the quantity of water available at the original point of diversion.

When required by the Department, the water user shall install and maintain headgates, in-line flow meters, weirs, or other suitable devices for measuring and recording the quantity of water diverted. The type and plans of the headgates and measuring devices must be approved by the Department prior to construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm additional points of diversion approved by an order of the Water Resources Director entered January 23, 1995, at Special Order Volume 49, Page 30, approving Transfer Application 6568, and supersedes Certificate 67548, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
