confirms the right to use the waters of BOARDMAN WELL, tributary of the FORT ROCK BASIN for IRRIGATION of 46.0 ACRES.

This right was perfected under Permit G-10925. The date of priority is APRIL 4, 1989. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.58 CUBIC FOOT PER SECOND, if available at the original well, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This certificate is issued to confirm a change in POINT OF APPROPRIATION AND PLACE OF USE approved by an order of the Water Resources Director entered August 30, 1995, at Special Order Volume 49, Page 291, approving Transfer Application 7300, and together with Certificate 68562, supersedes Certificate 68444, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
