CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

TOLLGATE WATER CO.
15004 SADDLE DRIVE
SISTERS OR 97759

confirms the right to use the waters of TWO WELLS in the DESCHUTES RIVER BASIN for QUASI-MUNICIPAL USE.

This right was perfected under Permit G-6798. The date of priority is JUNE 25, 1975. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.30 CUBIC FEET PER SECOND (CFS) being, in any combination, no more than 0.95 CFS from Well No. 1 and 0.82 CFS from Well No. 2, and further limited in conjunction with Permit G-12339 to a maximum rate of 2.06 cubic feet per second and a maximum duty of 112 million gallons per year, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.


This certificate is issued to confirm a change in the character of use approved by an order of the Water Resources Director entered June 3, 2008, at Special Order Volume 75, Page 132, approving Transfer Application T-9610, and supersedes Certificate 82119, State record of Water Right Certificates.

The wells shall be maintained in accordance with General Standards for the Construction and Maintenance of Water Wells in Oregon.

The water user shall maintain and operate the existing measurement device and shall make such future improvements as may be required by the Department.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
